

A Message from the NC Chapter of The Wildlife Society:

Since the 2012 announcement that Raleigh was selected to host the 23rd Annual Conference of The Wildlife Society (TWS), members of the North Carolina Chapter of TWS (NCTWS) have looked forward to welcoming our colleagues to the premier wildlife science and networking event of 2016. Over the past 16 months, scores of NCTWS members have been planning and organizing a top-notch conference. Hosting this gathering of wildlife professionals and students has been a galvanizing focus of chapter work that we've approached with energy and excitement.

Over the past few weeks, the passage of the [Public Facilities Privacy & Security Act](#) (also referred to as House Bill 2, or HB2) has cast an unfortunate shadow over North Carolina and has caused several states and municipalities to prohibit non-essential travel to North Carolina, which includes the TWS conference. In addition, TWS members have expressed concern about traveling to North Carolina and are withdrawing from attending the conference. As the state chapter hosting this conference, we feel it's our responsibility to respond, as we want our guests to feel welcome to our state.

TWS has a long record of support for fairness and equality and equal protection under the law, which is articulated quite clearly in the TWS standing position statement on [Workforce Diversity in the Wildlife Profession](#). That statement talks at length about inclusiveness, engagement, and enfranchisement of all citizens, including a diversity of culture, spiritual views, and sexual orientation, and is fundamental to our concept of what TWS stands for.

Our chapter fully supports the TWS position on Workforce Diversity, and will continue to work hard to assure a welcoming and supportive conference environment for all attendees. We've looked forward to sharing our state's natural heritage and southern hospitality, and HB2 will not change our chapter's efforts to show that true southern hospitality is welcoming and inclusive to all people, including our LGBTQ attendees.

In addition, we would like to provide a few excerpted quotes from statements published after the legislative action from the Greater Raleigh Convention and Visitors Bureau and the Mayor of Raleigh.

“Respect for diversity and inclusion remains a constant for our staff and area hospitality partners as well as for our valued visitors. Raleigh, N.C., is a diverse community shaped by a culture of respect and inclusiveness for all of its citizens and visitors...” from the [Greater Raleigh Convention and Visitors Bureau](#).


“Raleigh is a welcoming, diverse city that draws its strength from many areas. We have always been a place where people respect each other's differences and understand that those differences make us stronger. Raleigh
